## **BY-LAW NO. 227/60**

A By-law requiring the numbering of streets, avenues, and premises of the Village of Bentley.

WHEREAS it is expedient for the Village of Bentley to pass a By-law requiring the numbering of streets, avenues and premises,

THEREFORE, be it enacted by the Council of the Village of Bentley as follows:

- 1. That the street formerly known as Murray Street shall hereinafter be known as 50th Street. Streets west of 50th Street shall be numbered up consecutively and streets east of 50th Street shall be numbered down consecutively according to the map, being Schedule "A" of the By-law.
- 2. That the avenue formerly known as McPherson Avenue shall hereinafter be known as 50th Avenue. The avenues north of 50th Avenue shall hereinafter be numbered up consecutively and the avenues south of 50th Avenue shall be numbered down consecutively according to the map, being Schedule "A" of this By-law.
- That house numbering on avenues shall commence at each street intersection and with even numbers on the north side of each avenue and odd numbers on the south side of each avenue, continuing numbering upwards in a westerly direction until the intersection of the next street. That the first digits in the property number shall indicate the street from which the numbering commenced, the last two digits of the number being the number of the house as arrived at from this system.
- 4. That the house numbering on streets shall commence at each avenue intersection, and with even numbers on the west side of each street and odd numbers on the east side of each street continue numbering upwards in a northerly direction until the intersection of the next avenue. That the first digits in the property number shall indicate the number of the avenue from which the numbering commenced, the last two digits being the number of the house as arrived at from this system.
- 5. That the numbers assigned to each building site taking into consideration the size of the lots in that particular residential or business area concerned.
- 6. That it shall be the duty of every property owner, at his own expense, to have property numbers shown on or near the front entrance, on or before the 31 day of December, 1961. Said numbers shall be prominently displayed, shall be at least three (3) inches in height and painted in a contrasting color that can easily be ready from the street or avenue. It shall be the duty of all property owners to first ascertain the proper number by inquiring at the Village Office.
- 7. That the Village authorities shall as soon as practical erect at each intersection a post showing street and avenue numbers, cost of same to be paid by the Village of Bentley.

That any person or persons violating the provisions of this By-law or not complying with the requirements as set out herein, or any person destroying or tampering with, or changing any number or sign post placed in compliance with this By-law shall, on Summary Conviction before any Justice of the Peace or any Police Magistrate having jurisdiction in the Village of Bentley, be liable to the penalties provided in By-law No. 83 of the Village of Bentley for the infraction of the By-laws of the Village of Bentley.

READ a first, a second and a third time and finally passed this 26 day of October, 1960.
