- Each event must have proof of insurance with the Town named as 3. Additional Named Insured. All renters must sign the waiver form, shown as "Schedule B".
- All rental fees must be paid in advance, with the proof of insurance 4. provided at that time. If insurance is purchased through the Town's insurer, then payment for such insurance must be made prior to the event.
- Town staff will open and close the arena for each event. No keys 5. will be issued to hourly renters.
- An inspection will be completed by Town staff after each event. 6. Any damages incurred on equipment, either outside or within the Arena, will be repaired by Town staff and the renter will be charged accordingly.
- Lobby and washroom cleaning will be completed by Town staff. 7.
