Alberta Environment. Standards & Guidelines for Municipal

Waterworks, Wastewater and Storm Drainage Systems. 2006, p. 7.1.1

states: "The proper operation and maintenance of wastewater

systems is essential to produce the highest quality of treated effluent and to ensure the protection of the public health and the environment".

Alberta Environment. Code of Practice for Wastewater Systems Using a Wastewater Lagoon, p. 7, Section A 4.1.7 states "The structural integrity of all portions of the wastewater lagoon shall be maintained as set out in the engineering design drawings and specifications"

Municipal Government Act. 2010, p. 34, Section 3 (b) (c) states: "to provide services, facilities or other things that, in the opinion of council, are necessary or desirable for all or a part of the municipality

and to develop and maintain safe and viable communities".

Purpose:

To establish a regular practice of sanitary manhole inspection and

maintenance

To establish a regular practice of lagoon inspection and maintenance

To ensure proper effluent treatment

To comply with Alberta Environment Code of Practice

To reduce exposure to risk and liability

To ensure uninterrupted effluent removal and treatment To preserve a core infrastructure asset of the Town



**Definitions:** 

The term "manhole" refers to the lid, collar, rings, barrel, benching, trough and ladder.

The term "main lines" does not include service line connections

The term "sanitary lagoons" refers to eight ponds, flume, intake meter, gate valves, level control boxes, outfall overflow, outfall line, outfall valve, three outfall manholes and the Blindman River inlet.

Policy Statement: Sanitary sewer manholes shall be inspected annually, following Standard Operating Guidelines.

> A consecutive portion of the Town's sanitary sewer main lines shall be flushed annually, following Standard Operating Guidelines.

A regular inspection of the lagoon storage cells (condition and capacity) shall be undertaken, following Standard Operating Guidelines.

A regular inspection of the lagoon intake flume shall be undertaken to ensure an unobstructed flow and to discover any blockages that may occur. The regular schedule of intake meter readings will be undertaken, with records kept, following Standard Operating Guidelines.

Any deficiencies/problems found shall be addressed/corrected as soon as possible (subject to financial resources available).

This policy shall be adhered to by the Public Works Department and is subject to the financial and manpower resources of the Town.
