

# **LRWSC Operations**

- Dry Rubble Any non-hazardous waste that does not rapidly decompose (Drywall, insulation, furniture).
- Municipal Solid Waste (MSW) Non-hazardous waste containing rapidly decomposing materials (Food, Compost).
- LRWSC landfills under 10,000MT of Non-hazardous Dry Rubble every year. We are bound by the Code of Practice for Landfills through Alberta Environment to keep our Landfill annual totals under 10,000MT.
- LRWSC collects at each site approx. 9500MT compacted Municipal Solid Waste (MSW) and transports the waste to the West Dried Meat Lake Landfill Class 2 facility in the County of Camrose.
- LRWSC collects approx. 1000MT of Dry Rubble at the four remote sites, and transports back to the Prentiss Landfill.
- LRWSC collects approx. 300MT of waste metal at the four remote sites, and transports back to the Prentiss Landfill.

# Reasons for Refusal at Remote Sites

Our site attendants will refuse loads for the following reasons:

- Load is more than 500kg or larger than a pick up truck box.
- Shingle loads.
- HHW, paint, and oil loads.
- Unacceptable waste (Industrial, Hazardous)
- Not a Lacombe County tax paying resident.

All refused Lacombe County waste is directed to the Prentiss Facility.




# Tourism = Visitor Economy





The LRT would like to ask that the Town of Bentley consider joining the LRT as a full member of the association.



### **COVID-19 UPDATE**

Council was provided with an update on the latest COVID-19 restrictions, statistics and the Province's current vaccine statistics.

#### **ROAD CLOSURE REQUEST – ROAD PLAN 3593J – CONSOLIDATION & SALE**

At the November 30, 2021 meeting, by resolution, Council instructed the County Manager to proceed with the process to close Road Plan 3593J and that this proposal be circulated to interested parties for comment. Council was informed that there were no objections received from government agencies, utility companies or adjacent landowners.

The following resolution received the approval of Council and will be forwarded to the Minister of Alberta Transportation for approval:

*IN THE MATTER of the closure to public travel and canceling a public highway in accordance with Section 24 of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta 2000, as amended;* 

WHEREAS the land hereafter described is no longer required for public travel;

NOW THEREFORE BE IT RESOLVED that the Council of Lacombe County does hereby close the following described road, subject to the rights of access granted by other legislation or regulations:

1) Plan 3593J lying within the SW 8-41-24 W4M (4.17 acres +/-)

Excepting Thereout All Mines and Minerals

for the purpose of the consolidation of the 4.17 acres +/- with the lands in the Certificate of Title 202 096 153 +1 for the SW 8-41-24 W4M.

### **RE:** Town of Bentley Application

Good afternoon Mr. Calkins

The Town of Bentley appreciates your efforts and passion for the communities that you represent including our community. As you are aware, we recently applied for a grant with the Canada Community Revitalization Fund to replace our aging arena slab. Mayor and Council would like to thank you for your letter of support, which was submitted with our application.

As per your letter of support, "like many small communities across our country, it thrives on personal connections and having a place to connect. The Bentley Arena is just such a place. It is more than just an ice rink. It supports the Farmer's Market, the Bentley Rodeo, the Wolf Creek Public School Hockey Academy, and is available for many community sports and recreation uses not just for the town, but neighboring communities as well."

Please note that funding is secured to cover the Town's portion of expenditure \$360.000 as well as a significant financial contribution from Lacombe County in the amount of \$360,000. The project will leverage the partnership between the County and Town as well as levels of Provincial and Federal government to complete it and make a difference in our community.

The Town CAO, Marc Fortais has been trying to connect with the representatives from the Grant Program for more than 6 months to understand if our grant will be approved or not. The message received back is the same, "The application is still in the review process. There has been a significant volume of applications, but they are continuing to work as quickly as possible to process each application. They will be contacting applicants if they have questions regarding their applications."

The timing of the work to be undertaken is significant as it will impact the Minor Hockey Schedule, or it will impact the possibility of hosting the Bentley Rodeo. We continue to be asked by those organizations and groups that may be affected if we have an update and if we will be proceeding with the slab replacement. Not only is the lack of notification impacting the Town, but it is impacting the ability of the Rodeo Committee and Minor Hockey to effectively plan for events for the 2022 year.

Without a notification, if we are successful or not, we are running out of time to undertake tender of the work and award to minimize the potential impacts for this year's construction season. We realize that with any community project and competing applicants, there may be impacts to other communities as well, however given the size of our community and the significance of this facility to the community of Bentley, we feel that there should be greater prioritization to providing us some certainty regarding the outcome of our application. The Town of Bentley Mayor and Council are formally asking you to contact The Honourable Daniel Vandal Minister of Northern Affairs, Minister responsible for Prairies Economic Development Canada and Minister responsible for the Canadian Northern Economic Development Agency, to ask that he connects with his staff to provide the Town of Bentley with an answer if we are successful or not with our application. This will allow the Town of Bentley to inform the many people that are affected by the project and allow for planning for the upcoming year.

We thank you for your continued support, care, and consideration that you will give to this request.
